BOUNDARIES: Lake Macquarie and all estuarine waters directly connected to Lake Macquarie. Eastern boundary from an imaginary line drawn between the eastern tip of the northern Breakwall to the "H" frame prominent on the Southern Shoreline,

RULES: The competition will be conducted in accordance with the NSWFCA By-Laws and NSW Fisheries Saltwater Regulations. Competitors are not permitted to weigh fish caught outside the stated fishing times.

WILL BE MADE FOR FISH PRESENTED GILLED & GUTTED.**
